POLICY RE: PAYMENT OF FEES

Fees for the school year 2018-2019 are \$14,500 + ESL costs for International Students, \$6,540 for Anglicans and \$6,850 for all others.

(10% reduction for second child, 50% reduction for third child and 75% reduction for fourth child)

Notice: *Fees are set by the Christ Church Cathedral Educational Society Board of Directors. They are reviewed annually and are set early in the year for the following school year.*

As Christ Church Cathedral School is dependent on fees to meet its budget, those parents or guardians enrolling children must agree to the following conditions:

1. Fees are payable in one of the following ways:

a. In full before August 31, 2018 **Or**

b. In two installments – on or before August 31st **and** on or before December 31, 2018 **Or**

c. Cheque to cover balance of tuition (less registration deposit) for September 2018 and Pre-Authorized Debit on the 1st or 16th of each month from Sep. 2018 (to cover June 2019) through May 2019. New forms for this preferred payment method will be forwarded to you before the end of June 2018.

NB: Pre-Authorized Debit forms must be completed every year to include any changes in fees and possible banking adjustments.

Note: Withdrawal at any time during the year means that the June pre-paid tuition will be forfeited. Also, parents are responsible for payment of the tuition up to and including the final day of any month in which a child is withdrawn.

2. If fees are paid in full before August 31, 2018 there will be a discount of \$50.00 or if the fees are paid in two installments before December 31, 2018 there will be a discount of \$25.00.

3. Anglican Parish affiliation must be supported by an offering envelope number.

4. Unless an extension is granted or the outstanding fees are received by the 25th of the current month, the child(ren) will be considered to have been withdrawn from the school and will not be allowed to attend as of the last day of that month.

5. If an account is in arrears at April 30th your child will not be offered a place at the School for the following year.

6. Notwithstanding items 1 - 5, if there are any difficulties regarding payment of fees, please contact the Head of School or the Sr. Administrative Assistant to discuss any options that might be available.
