Methods of Payment:

- Cash
 - e-transfer (to accounts@cathedralschool.ca)
 - Pre-authorized Debit (required for monthly payors)
 - Cheques (payable to **Christ Church Cathedral Educational Society**)
- Note that there is a \$25.00 fee for non-sufficient funds from cheques or PAD**

For Pre-Authorized Debit (PAD):

A VOID Cheque and a signed form for automatic withdrawal (PAD Form) is required in order to begin a monthly direct withdrawal from your banking institution. **Payment can be withdrawn from your account on the 1st or the 16th of each month. There is a \$25.00 fee for non-sufficient funds.**
